# Joint CWPP Advisory Group Update

The next major step is in process, which is getting the CWPP reviewed and approved by both the Metro and the HOA Boards of Directors.

There was a discussion about access via a second road in case of emergency. There is a road that exits Crystal Park off of Oak Ridge, but it is currently blocked by a private land owner. The HOA has been in contact with that land owner, but our needs are getting tangled up with an ongoing dispute between the land owner and the Town of Manitou Springs. Nothing has been resolved at this point.

#### Dispatch Status Update

Manitou Springs is planning to change its police and fire dispatch system beginning in January. They will no longer do it in-house: El Paso County will take on the dispatch for MSFD. It has fortunately been agreed that EPC will include CPVFD in its agreement with Manitou Springs, at no cost to us.

### Wal-Mart Grant Request

Woodland Park Wal-Mart rejected our request for 5K for wildland gear.
